#### b) 2023 SHOW STAND RESERVATION FEE

**Pre- Show Ticket** Ksh. 100 (To be used on 23rd May, 2023 at the Entry Gates per person)

**Judging Fee** Ksh. 1,500 (Charged per Trade Judging Class entered)

Cleansing Ksh 2,000

Essential Sticker Ksh 3,200

Theme Interpretation - Ksh 2,000 (This is compulsory to all Exhibitors)

Trade Attendant Ticket - Kshs 800 per person for 4 days

Judging will commence on 24th May 2023.

All entries to be in place by 8: 00 am on Wednesday 24th May 2023.

No Exhibitor should leave the Showground before 5:00pm on Saturday the 27th May 2023.
