Livestock except Horses will only enter the Showground through **KIBERA GATE**. This applies to all Livestock, whether in classes or Demonstration. Horses will enter through **GATE (E)**.

Cattle will be permitted to enter the Showground **ONLY** through the **SPRAY RACE** and after that they have been thoroughly soaked with accaricide solution. Cattle will be permitted to enter the showground up-to noon on Monday.
